NOTIFICATION

G. O. (P) No. 177/2015/LSGD. Dated, Thiruvananthapuram, 26th May, 2015  
12th Idavam, 1190.

**S. R. O. No. 338/2015.**—WHEREAS, in exercise of the powers conferred by clause (d) of article 243P and clause (2) of article 243Q of the Constitution of India, the Governor of Kerala, having regard to the population of the area, the density of population therein, the revenue generated for local administration, the employment in non-agricultural activities and the economic importance, is pleased to notify the areas comprised in Kondotty and Nediyruppu Village Panchayat specified in Schedule I to be smaller urban areas for the purpose of Part IX A of the Constitution of India with effect from the 1st day of November, 2015 and each area so specified shall be a Municipal area;

AND WHEREAS, Notification III issued under G. O. (P) No. 86/94/LAD, dated 20th April, 1994 and published as S.R.O. No. 470/94 dated 20th April, 1994 in the Kerala Gazette Extraordinary No. 351 dated 20th April, 1994 was amended by notification issued under G. O. (P) No. 148/2015/LSGD, dated 30th April, 2015 and published as S.R.O. No. 263/2015 in the Kerala Gazette Extraordinary No. 1054 dated 30th April, 2015;

AND WHEREAS, the area of the existing Thalakkulathur Village Panchayat and ward numbers 1, 2, 3, 4, 5 and 75 of Kozhikode Municipal Corporation was notified as smaller urban area for the purpose of Part IX A of the Constitution of India with effect from the 1st day of November, 2015 as per Notification issued under G. O. (P) No. 148/2015/LSGD, dated 30th April, 2015 and published as S.R.O. No. 263/2015 in the Kerala Gazette Extraordinary No. 1054 of 30th April, 2015, the same has not been included in the Schedule I to the said notification;

NOW, THEREFORE, consequential following further amendments are made to the Notification III issued under G. O. (P) No. 86/94/LAD, dated 20th April, 1994 and published as S.R.O. No. 470/94 dated 20th April, 1994 in the Kerala Gazette Extraordinary No. 351 dated 20th April, namely:---

#### AMENDMENTS

In the said Notification, in SCHEDULE I, (Smaller urban areas) after serial number 90, and the entries against it, the following serial numbers and entries shall respectively, be added, namely:---

“91. Territorial area of the existing Thalakkulathur Village Panchayat and Ward No. 1, 2, 3, 4, 5 and 75 of Kozhikode Municipal Corporation.

92. Territorial area of the existing Kondotty and Nediyruppu Village Panchayat.

93. Territorial area of the existing Faroke Village Panchayat.”

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per clause (d) of article 243P and clause (2) of article 243Q of the Constitution of India, the Governor of Kerala, having regard to the population of the area, the density of population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance or such other factors as he may deem fit, specify by public notification for the purpose of Part IX A of the Constitution such area as a 'transitional area', 'a smaller urban area' or 'a larger urban area'.

Having regard to the population of the area, the density of population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance the Governor of Kerala have decided to notify the existing areas of Kondotty and Nediyruppu Village Panchayats in Malappuram District and Faroke Village Panchayat in the Kozhikode District as smaller urban areas. Further Thalakkulathur Village Panchayat in Kozhikode District and Ward numbers 1, 2, 3, 4, 5 and 75 of Kozhikode Municipal Corporation has been notified as Smaller urban areas, vide S.R.O. No. 263/2015 dated 30th April, 2015 published in the Kerala Gazette Extraordinary No. 1054 of 30th April, 2015, but the same was not included in the Schedule I to the said notification. Hence it was decided to include the said entry as entry 91 in the Schedule to the notification and territorial areas of existing Kondotty and Nediyruppu Village Panchayats and territorial areas of the existing Faroke Village Panchayat as entries 92 and 93.

The notification is intended to achieve the above objects.
