**Order**

The Chairman, State Delimitation Commission as per letter read above has requested to issue appropriate orders for the Preliminary arrangements for the functioning of the State Delimitation Commission as given below .

1. **Office Accommodation**

The Delimitation Commission requires an Office close to the office of State Election Commission and the Directorate of Panchayats and an Office hall of about 1100 Sq.ft. is available at the L.M.S. Complex and it is learnt that the owner is ready to allot the space at a rent of Rs.25/sq.ft.

2. **Appointment of Staff to the Commission**

Considering the volume of work entrusted with the Commission, the post of 1 Senior Superintendent on deputation, 5 Assistants - 3 posts on deputation and 2 on redeployment from other offices, 3 Data Entry Operators on daily wages, 1 Office Attendant on redeployment, Driver on redeployment and 1 Sweeper on daily wages are needed in the office of the Commission.

Sanction for the above posts and appointment of Sri.K.Prasanth kumar, Secretary, Pulimath Grama Panchayat as Senior Superintendent and Sri. K.S.Kishor, Junior Superintendent, Poovachal Grama Panchayat as Assistant on deputation basis in KSUDP, is needed to start the preliminary works of the Commission.

3. Sanction for the Purchase of Furniture, Photocopier, Computer and accessories, providing telephone & Broad-Band Connection is needed and funds be provided.

4. Providing funds for the Commission

An amount of Rs.1,00,000/- for meeting salary of the staff on deputation for the month of February, Rs.50,000/- for the payment of wages to the staff on daily wages and Rs.5,00,000/- for the procurements of office equipments and furniture etc.

Government have examined the matter in detail and are decided to accord sanction for the following as agreed by the Finance Department.

1. The proposal for the office space is approved.
2. Sri.K.Prasanth Kumar, Secretary, Pulimath Grama Panchayat be transferred to the Directorate of Panchayat and be posted as Senior Superintendent on working arrangement .
3. A suitable rearrangement be made in the Directorate of Panchayat for keeping the strength of Senior Superintendents in the existing level itself.
4. Sri.K.S.Kishor, Junior Superintendent, Poovachal Grama Panchayat, on deputation to KSUDP be deployed as Junior Superintendent on working arrangement basis (instead of Assistant, but total number in the proposal will not be changed)
5. 3 posts of Clerks be provided on working arrangement from other offices.
6. 3 posts of Data Entry Operators be provided on working arrangement from IKM.
7. Office Attendant be provided on working arrangement.
8. Post of Part Time Sweeper be provided on working arrangement.
9. Furniture be arranged from IKM.
10. Other IT equipments and Funds be arranged from the State Election Commission itself.
