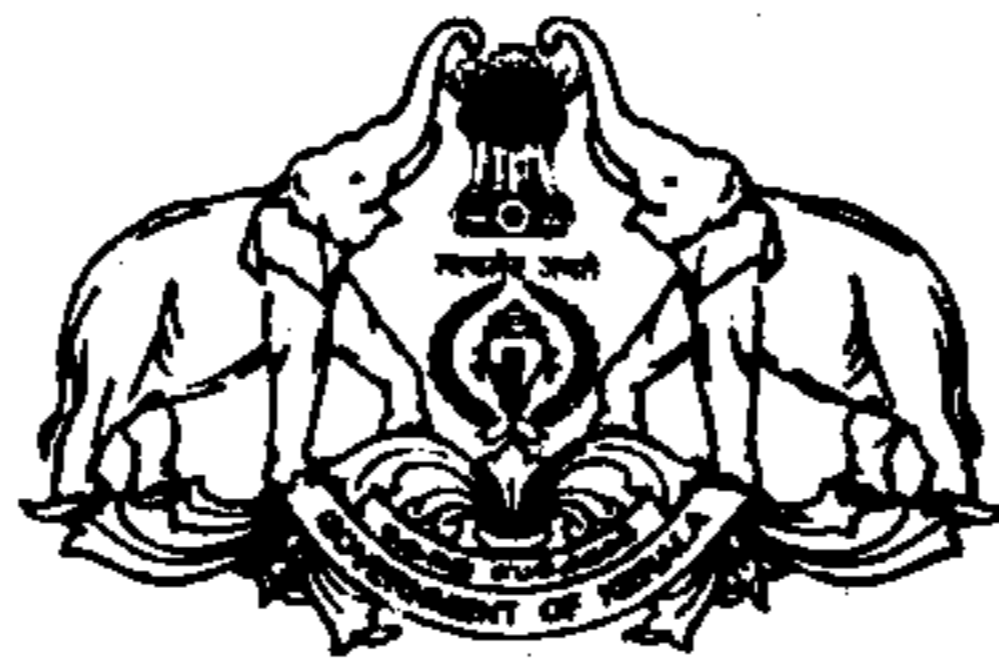

**S. R. O. No. 269/2015.**—In exercise of the powers conferred by clause (d) of Article 243P and clause (2) of Article 243Q of the Constitution of India, the Governor of Kerala, having regard to the population of the area, the density of population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance, is pleased to notify the areas specified in the Annexure hereto to be smaller urban areas for the purpose of Part IX A of the Constitution of India with effect from the 1st day of November, 2015 and each area so specified

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per clause (d) of Article 243P and clause (2) of Article 243Q of Constitution of India, the Governor of Kerala, having regard to the population of the area, the density of population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance or such other factors as he may deem fit, specify by public notification for the purpose of Part IX A of the Constitution such area as a 'transitional area', 'a smaller urban area' or 'a larger urban area'.

Having regard to the population of the area, the density of population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance the Governor of Kerala have decided to notify the existing areas of Grama Panchayats specified in the Annexure hereto as smaller urban areas.

The notification is intended to achieve the above objects.
