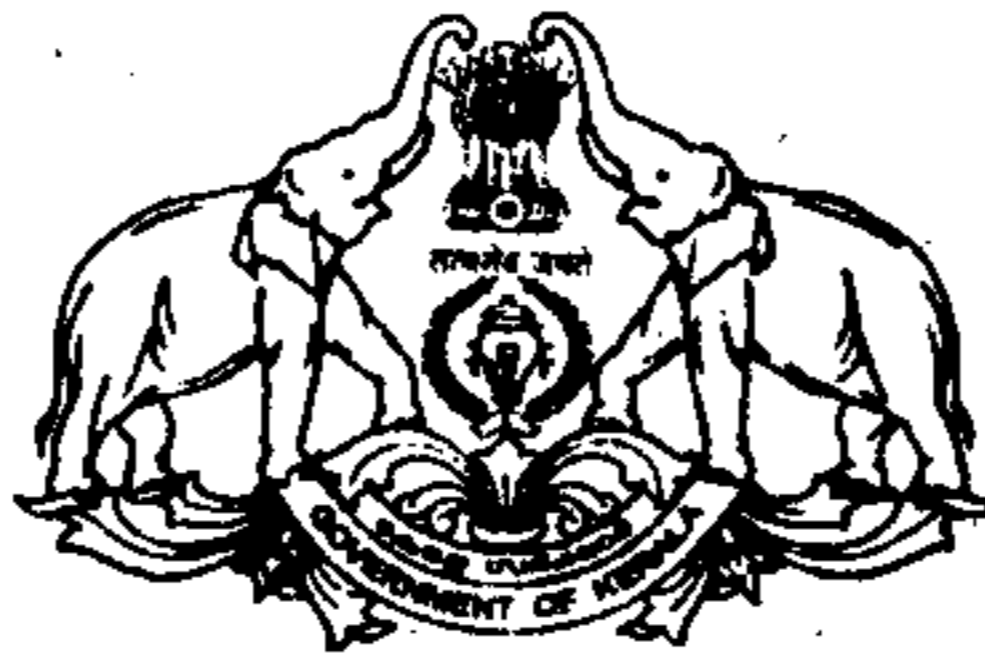

NOTIFICATION

G O. (P) No. 145/2015/LSGD. Dated, Thiruvananthapuram, 30th April, 2015
16th Medam, 1190.

S. R. O. No. 263/2015.—In exercise of the powers conferred by clause (d) of Article 243P and clause (2) of Article 243Q of the Constitution of India, the Governor of Kerala, having regard to the population of the area, the density of population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance, is pleased to notify the areas comprised in Ward Nos. 16-35 of Thaliparamba Municipality of Kannur District, the areas of Thalakkulathur Grama Panchayat in Kozhikode District, the areas comprising 132 houses of Azhithala region in Ward No. 1 of Padanna Grama Panchayat in Kasargod District, Ward Nos. 1, 2, 3, 4, 5 and 75 of Kozhikode Municipal Corporation, the areas comprised in

Ward Nos. 1, 2, 3, 4, 8, 9, 10, 11, 97, 98, 99 and 100 of Thiruvananthapuram Municipal Corporation, the Ward Nos. 40, 41, 42, 43, 44, 45 and 46 of Kozhikode Municipal Corporation, Ward numbers 47, 48, 49, 50, 51, 52 and 53 of Kozhikode Municipal Corporation to be smaller urban areas and the areas in Thrikkadavoor Grama Panchayat in Kollam District, areas comprised in Kannur Municipality and Pallikkunnu, Puzhathi, Edakkad, Elayavoor and Chelora Grama Panchayats to be larger urban areas for the purpose of Part IXA of the Constitution of India with effect from the 1st day of November 2015 and areas so specified shall be a Municipal area and consequently make the following amendments to the Notification No. III issued under G.O.(P) No. 86/94/LAD dated, the 20th April 1994 and published as S.R.O. No. 470/94 on the Kerala Gazette Extraordinary No. 351 dated the 20th April, 1994, namely:—

AMENDMENTS

In the said Notification.—

(1) in Schedule I (Smaller urban areas),—

(a) the existing entries against Sl. No. 3 “Territorial area of the existing Kannur Municipality” shall be omitted;

(b) for existing entries “47 Territorial area of the existing Thaliparamba Municipality” the following entries shall be substituted, namely:—

“47. Territorial area (except ward No. 16-35) of the existing Thaliparamba Municipality.”

(c) for the existing entries, “61. Territorial areas of the existing Neeleswaram Grama Panchayat” the following entries shall be substituted, namely:—

“61. Territorial areas of the existing Neeleswaram Grama Panchayat and areas comprising 132 houses of Azhithala region in Ward No. 1 of Padanna Grama Panchayat.”

(d) after Serial Number 86 and the entries against it: the following serial numbers and entries shall respectively be substituted, namely:—

“87. Territorial areas of Ward No. 16-35 of Thaliparamba Municipality (Andoor Municipality).

88. Territorial areas of 1, 2, 3, 4, 8, 9, 10, 11, 97, 98, 99 and 100 of Thiruvananthapuram Municipal Corporation (Kazhakuttom Municipality).

89. Territorial areas of ward 40, 41, 42, 43, 44, 45 and 46 of Kozhikode Municipal Corporation (Cheruvannur-Nallalam Municipality).

90. Territorial areas of ward numbers 47, 48, 49, 50, 51, 52 and 53 of Kozhikode Municipal Corporation (Beypore Municipality).”

(2) in Schedule II (Larger urban areas),---

(a) for the existing entries “1. Territorial area of the existing Thiruvananthapuram Corporation and areas comprised Sreekariyam, Vattiyoorkavu, Kudappanakkunnu, Vizhinjam and Kazhakuttom Village Panchayat,” the following entries shall be substituted, namely:---

“1. Territorial area except Ward Nos. 1, 2, 3, 4, 8, 9, 10, 11, 97, 98, 99 and 100 of Thiruvananthapuram City Corporation areas comprised in Sreekariyam, Vattiyoorkavu, Kudappanakkunnu, Vizhinjam and Kazhakuttom Village Panchayat.”

(b) for the existing entries “3. Territorial area existing Kozhikode City Corporation and areas comprised in Elathur, Cheruvannur-Nallalam and Beypore Village Panchayats”, the following entries shall be substituted, namely:---

“3. Territorial area except ward Nos. 1, 2, 3, 4, 5, 40, 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53 and 75 of Kozhikode Municipal Corporation.”

(c) for the existing entries “4. Territorial area of the Kollam City Corporation” the following entries shall be substituted, namely:---

“4. Territorial area of the Kollam City Corporation and Thrikkadavur Grama Panchayat.”

(d) after the entry 5, the following entry shall be inserted, namely:---

“6. The Territorial areas comprised in the existing Kannur Municipality, Pallikkunnu Grama Panchayat, Puzhathi Grama Panchayat, Edakkad Grama Panchayat, Elayavoor Grama Panchayat and Chelora Grama Panchayat (Kannur Municipal Corporation).”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per clause (d) of Article 243P and clause (a) of Article 243Q of Constitution of India, the Governor of Kerala, having regard to the population of the area, the density of population therein, the revenue generated for local administration, the percentage of employment in non-agricultural activities and the economic importance or such other factors as he may deem fit, specify by public notification for the purpose of Part IXA of the Constitution such area as a 'transitional area', 'a smaller urban area' or 'a larger urban area' and as per clause (d) of Article 243P the Governor may notify such area as Municipal area.

Government have decided to constitute Andoor Municipality, Kazhakuttom Municipality, Elathur Municipality, Cheruvannur-Nallalam Municipality and Beypore Municipality by bifurcating/merging the Thaliparamba Municipality, Thiruvananthapuram Municipal Corporation, Kozhikode Municipal Corporation respectively the areas comprising 132 houses of Azhithala region in ward No. 1 of Padanna Grama Panchayat in Kasargod District to be smaller Urban Areas and areas in Thrikkadavoor Grama Panchayat in Kollam District and areas comprising Kannur Municipality, Pallikkunnu Grama Panchayat, Puzhathi Grama Panchayat, Edakkad Grama Panchayat, Elayavoor Grama Panchayat and Chelora Grama Panchayat to be larger urban areas.

The notification is intended to achieve the above object.
